

**MINUTES OF THE MEETINGS OF THE ALLAMAKEE COUNTY BOARD OF SUPERVISORS  
MONDAY, MARCH 9, 2009**

Board met as preadjourned. Board members present Campbell, Kuhse, and Burke. All members voting "AYE" unless noted.

09.089-Motion by Campbell and second by Kuhse to approve agenda & minutes from March 2, 2009 with the addition of the individual county farm bids for the cropland (John & Jim Regan \$175/ac, Kevin Bentien \$227/ac, Paul Regan \$236.01/ac, George & Ed Bieber \$177.33/ac, Steve & Francis Stortz \$147/ac, Chase Regan \$201/ac, Brian Stortz \$187/ac) and the pasture land (Regancrest \$5,000/yr, Stan Martins \$5,020/yr, Matt Rea \$2,700/yr, Bobby Ryan \$2,025/yr, George & Ed Bieber \$7,600/yr, Steve & Francis Stortz \$2,100/yr, Brian Stortz \$6,900/yr). Motion carried.

09.090-Motion by Campbell and second by Kuhse to set March 23, 2009 at 9:30 am for a Public Hearing on proposed Mental Health/Developmental Disabilities Management Plan & Strategic Plan for FY10-12. Motion carried.

Chris Dahlstrom & Tim Heidersheit present.

09.091-Motion by Campbell and second by Kuhse to approve Stray Dog Resolution with the correction of \$10 per dog per day. Motion carried.

09.092-Motion by Campbell and second by Kuhse to accept Paul Regan's bid of \$236.01/ac for rent of county farm crop land. Motion carried.

09.093-Motion by Campbell and second by Kuhse to accept George & Ed Bieber's bid of \$7,600/yr for rent of county farm pasture land. Motion carried.

Brian Ridenour present.

Brian Ridenour had bids for road striping and said the start date is set for June 8<sup>th</sup>.

09.094-Motion by Kuhse and second by Campbell to accept Kam Line Highway Markings bid of \$49,776.35 for striping project. Motion carried.

Discussion was held about brush removal and clean-up that needs to be done at the County Farm. Burke mentioned possible cost share available. Kuhse will check into this.

Ridenour had bids from the DOT letting for the X-52 Concrete Overlay project, approx 3.2 miles of road.

09.095-Motion by Campbell and second by Kuhse to accept low bid of \$1,169,944.25 from Concrete Foundations, Inc for Hwy X-52 Concrete Overlay project. Motion carried.

Ridenour also updated the Board of other projects in process around the county.

Chris Dahlstrom informed the Board the State is going to be reallocating some to the funds available for the Community Disaster Grant and the new totals should be out this week. Dahlstrom & Ridenour have been working on getting bids for the generator.
